

## Local Law No. 2 of the year 2013: Local Traffic Laws

1. The purpose of this Local Law shall be to promote the safety and general welfare of the Village of Nunda, including the protection and preservation of the peace and good order by adopting and enforcing certain regulations, rights and privileges of the residents of the Village of Nunda and by imposing restrictions upon parking and traffic flow in the Village limits.
2. The Village Board will maintain schedules of two-hour parking areas, one-way streets, no-parking areas, handicapped-parking areas, speed limits and any other restrictions upon parking and traffic flow in the Village limits, and that a majority vote of the Village Board will be required to change any of these schedules. Any change in schedule that would impact state highways must be approved by NYSDOT before taking effect. All changes in schedules will be advertised in a timely manner before taking effect, and appropriate changes in signage will be made.
3. The Village of Nunda will be empowered to issue extended parking permits for extended parking in limited-time parking areas, to be used for special events, special needs, etc. The Village Board will develop procedures for organizations, businesses, groups and individuals to apply for such extended parking permits, effective time-periods, requirements, etc
4. The Village encourages merchants, individuals and businesses to communicate with each other regarding their parking needs and concerns, and to try to work out any difficulties before resorting to Police or Government intervention.
5. Until the Village has developed the schedules referenced in item #2 above, the current restrictions and regulations on parking and traffic flow in the Village shall remain in effect with the following exceptions:
  - A van-accessible handicapped parking space will be placed within the Municipal Parking Lot to be located in the State Street entrance next to and west of the sidewalk and on the north side of the entrance.
  - A van-accessible parking space will be added to the Mall Parking Lot. All other handicapped parking spaces will be eliminated.
  - The exit from the Mall Parking lot will be designated "Right-Turn Only".
  - Appropriate signage will be placed for all restrictions and regulations on parking and traffic flow,
  - There will be no parking in the Mall Parking Lot nor on any streets or highways (including curb lawns and driveway aprons) in the village between the hours of 2AM and 6AM at any time of year.

6. Repeals (conflicting ordinances and laws) All other ordinances or laws of the Village of Nunda that are in conflict with this law are hereby repealed to the extent of such conflict.
7. Severability: If any part of this law shall be held invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this law.
8. Applicability: This local law shall take effect upon its filing with the New York State Secretary of State.
