# Visitor's Forum

A. Marcia Underwood: Food Wagon Business – Ms. Underwood is interested in setting up a Food Wagon Business. Chad Bugman has offered a spot on his property, the old Agway Building, for a 16 ft. long wagon. Business would be on the weekends, and during the summer when school is out of session. Board referred her to Shawn Grasby, CEO/Zoning Officer for possible Zoning Permit. Would also need Health Department Permits.

B. Jessica James: No Parking – Ms. James received a Parking Ticket on 4/12/2014, dated for 2013, for parking between the sidewalk & the road during the hours of 2 AM & 6 AM. She stated that her property does not have a driveway due to space limitations and the configuration of the property itself that would force her to park on some else's property. She took her ticket to the Court, she was instructed to take her ticket to the Chief of Police, and was further instructed to bring it to the Village Board. Mayor Cox responded that he was aware that she has permission to park in the Trinity Church parking lot. He stated that the Parking Laws have been advertised in the Mt. Morris Shopper. A study had been done for over a year which led to slight changes. He also stated that enforcement is sporadic due to having a part-time Police Department. The Board instructed Ms. James to take her ticket back to Court because it is not valid with the wrong date.

Clerk Gray was instructed to advertise the 2AM to 6AM Parking Restrictions again in the Mt. Morris Shopper and to research the history of changes to the Village Law.

C. Lu Pierce: Garden Club – Asked to be removed from agenda

D. Gary Brink: Liberty, Website – Mr. Brink congratulated the Mayor for his coverage seen on TV driving the Shriner's Car. He went on to state his complaints with the Liberty, hired by NYSEG, for ruining the road on Center St., cutting the pavement in 8 places and not wetting it down during the process. "It's like driving down a dirt road." There are cracks on the street that need to be repaired.

Mayor Cox responded that contractor will restore the street to it's prior condition, however it will not be repaved, only patched. The contractor is working to have everything completed by Nunda Fun Days. Mr. Brink reiterated that the dust does not need to be flying. Changing the subject, Mr. Brink stated his dissatisfaction with the Village website being taken down. Hopefully, the Board will make better decisions in the future regarding the hosting of the site itself. Clerk Gray offered to scan and email the packet to anyone wishing to receive it.

Privilege of the floor given to Mel Allen, former officer of the Nunda Police Department. Mr. Allen lives at Mill & Walnut St. He would like "No Parking Signs" posted on his side of the street. He stated his frustrations with a neighbor holding a card party and the parking issues/violations that occur. A letter will be sent from the Village to the folks hosting the regular card parties. Mr. Allen continued to state his opinion that the Police Department is out of control regarding the issuance of parking tickets, driving violations, etc. Yet, they drive the wrong way out of the Mall in order to park in front of the Police Station. He also informed the Board of an issue with a parked car at Church & Walnut St. that forces the elderly and students to walk around the car into the streets. Lastly, he does not believe he updates to the Parking Laws are legal. A person should be able to park on their own property, regardless of being in the right-of-way, as long as they are not on the street.

Privilege of the floor given to Betty Adam. Mrs. Adam stated her complaint regarding the shortness of notice for a Zoning Board of Appeals meeting for which her property was located in proximately of the variance being requested. She had no time to respond since she was in Florida for the winter. The notice arrived after the ZBA hearing. Procedures will be researched.

A. Val Griffing, Town Historian: Video Presentations – Two videos, narrated by Tom Cook, were posted on the Historical Society webpage on April 26<sup>th</sup>. They have been viewed 4,000 times on Facebook, with 50 hits on YouTube.
