B. 2025/2026 Budget Adoption

Resolution No. 2025-11 2025/2026 Budget Approval

BE IT RESOLVED that the Nunda Village Board of Trustees approve the 2025/2026 Budget as presented with the following Appropriations: General Fund \$974,316.00 with \$563,000.00 to be raised by Taxes, Water Fund \$371,392.00, Sewer Fund \$254,670.00, and Youth Recreation \$30,321.00. Such budgets include the mayor's salary of \$2,000; Deputy Mayor \$2,500; and three Trustee positions at \$2,200 each – totals annual compensation.
